NOTIFICATION (REVISED)

In supersession to this office earlier notification No. KUST/Estt./Election/19/2838-42.

It is notified for the information of all concerned that under Section 22(1) (i) of the Khyber Pakhtunkhwa Universities Act, 2012 as amended till date; the election will be held on **April 26, 2019 from 08:30 a.m. to 03:30 p.m. (PST)** at the Central Library, KUST.

1. For **Syndicate** election to the constituencies (i.e. One Professor, One Associate Professor, One Assistant Professor and One Lecturer, one Chairman/Director of teaching department/Institute, **two** administrative officers of the University as per provision in the Act, to be elected by teachers of their respective cadres and administrative officers in the manner as may be prescribed by statute;) of **Syndicate** for a period of three years.

2. For **Senate** one lecturer, Assistant Professor, Associate Professor and Professor each has to be elected for three years.

3. For **Academic Council** one Associate Professor, two Asstt. Professors and two lecturers are to be elected for the period of three years.
