NOTICE INVITING TENDER

1. The Kohat University of Sciences and Technology (KUST) Kohat intends to construct a Jamia Masjid at KUST, Kohat. Therefore sealed bids are invited from the well reputed construction firms for “Construction of JAMIA MASJID at KUST, Kohat” Contracting firms must have a valid License of Constructor in relevant category with Pakistan Engineering Council (PEC) Islamabad. Bidding is on the basis of National Competitive Bidding (NCB) in accordance with “Single Stage-Two Envelope Bidding Procedure” comprising of “Technical & Financial Bids” as per latest KPPRA rules. .
2. Only eligible bidders with the following qualification should participate in bidding and must fulfill the requirements given in Tender Documents:

3. Sealed Bids must be accompanied by a Bid Security as mentioned above in the form of Call Deposit Receipt (CDR) / Bank Draft from the Scheduled Bank of Pakistan in the name of Treasurer, Kohat University of Sciences and Technology (KUST) Kohat.
4. A complete set of bidding documents may be purchased by eligible interested bidders on submitting a written application to the undersigned office on the original company letter pad upon payment of a non-refundable fee of PKR 2500/- (Rupees twenty Five Hundreds only). The sale of bidding documents will be closed on **14 -10 -2019** up to 1600 hours.
5. A pre-bid meeting shall be held on **09-10-2019** at 1000 hours in the Committee room, Kohat University of Sciences and Technology (KUST) Kohat. Bidders are invited to attend the meeting.
6. Conditional, incomplete, unsigned and bid filled with lead pencil are not acceptable at all.

7. Usage of correction fluid & corrections are strictly prohibited unless duly initialed.
8. The Contractor must provide 2 copies of their bids along with the one original bid.
9. KUST may ask for further information & details time to time if required.
10. In case of tie, decision will be taken through free toss which will be abides upon all the concerned contractors.
11. Registered with the Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013) for works, consulting and non-consulting services as listed in scheduled-II of the Act *ibid*.
12. Renewed their registration / documents for the year 2019-20 with communication and works Department.
13. All Taxes i.e. income Tax, Professional Tax, Sales Tax and Stamp Duty or any other Govt. Tax will be recoverable as per directives of the Government issued from time to time.
14. The bidders who quotes their bids/rates more than 10% below will submit additional security @ 8% needs to be deposited at the estimated cost vide “ KPPRA amendment notification No. KPPRA/M&E/Estt:/1-5/2016 dated 06.06-2017 otherwise his bid will be consider as Non-responsive. In that case the 2nd lowest bidder will be considered accordingly.
15. The Tender documents through courier must reach on or before **11:30AM**, dated **15-10-2019** to Directorate of Works, Kohat University of Science and Technology Kohat. The tender documents will be opened on the same day at **12:00 PM** in presence of the works committee and the bidders in the University Committee room at KUST Kohat.
16. The work will be executed up to the available fund. The contractor will have no right to claim any additional charges on account of delay in making the payment of the work done because of non receipts of funds in time.
17. The authority reserves the right to accept/reject or all the application/ tenders as per KPPRA rules.
18. At the time of issuing tender the contractor have to produce last three years annual audit reports and affidavit that the firm has not been blacklisted by any Govt. Department.
